The board of directors (the "Board") of the Company wishes to announce that CSRC, in compliance with the laws, has reviewed the application materials for administrative permission of the "Application for Approval of the Non-public Issuance of New Shares of Sinopec Oilfield Service Corporation" (《中石化石油工

程技術服務股份有限公司上市公司非公開發行新股核准》) and issued “CSRC’s Acceptance Notice of the Application for Administration Permission” (No.172296) (《中國證監會行政許可申請受理通知書》(172296 號)) (the “Acceptance Notice”). Pursuant to the Acceptance Notice, CSRC considered that the application materials in relation to the A Share Issue of the Company were complete and had complied with the statutory form and therefore it decided to accept the application for administrative permission for further processing.

The A Share Issue is subject to the approval by the CSRC and it is uncertain whether the A Share Issue will be approved. The Company will disclose the relevant information based on the progress in a timely manner. Investors are advised to pay attention to the investment risks thereof.
